"Area 70 and these guidelines use and adopt the ideals expressed in *The A.A. Service Manual Combined With the Twelve Concepts for World Service . . .*"

From The A.A. Service Manual Combined with Twelve Concepts for World Service, p71 FAQ:

"When contributions from groups come to G.S.O., does G.S.O. make distributions to other service entities, such as the area, the district and intergroup/central offices? No. Because of autonomy for each service entity, contributions that come to G.S.O. are assumed to be for the G.S.B. Contributions with requests for distribution as such would be returned. Groups will want to decide through group conscience how much and to what entities contributions are to be made individually."

When groups or individuals contribute to Area 70 we understand that they expect Area 70 to use those funds to carry the message in Vermont through the activities of its committees and officers. We do not send excess funds to the General Service Board, nor do we send excess funds back to districts or groups. By the same token, if a district finds themselves with funds above their prudent reserve, they should not send money to Area or back to groups. Instead, we would encourage districts to find ways to utilize those funds to carry the message within their borders.
