Some of the responsibilities include serving as a resource to your district counterpart, monitoring your service email account and responding to inquiries, functioning as a member of the Area Committee in service to the groups and membership in Vermont, attendance at the 4 FAAs and 7 Area Committee Meetings (ACM) each year, setting up service displays at FAAs, the Area 70 Convention, and other AA service events, and partnering with your district counterparts (if they choose) to find creative and constructive methods of ensuring that Alcoholics Anonymous is known and accessible throughout Area 70 (Vermont).

What is a "Full Area Assembly" anyway??

Also known as the FAA, this is the service and fellowship gathering for all members across Vermont. There's no cost to attend, no registration, and it's very informal! Dress is casual, so come in jeans or whatever you like and check it out! A typical "FAA" starts with light breakfast and fellowship at 9am followed by a 10 am Service Workshop, 11 am Committee Meetings (you can sit in on any committee that interests you), Delegate/D.C.M. meeting, 12 noon full lunch, and 1 pm Business Meeting. You don't have to hold a service postion, but GSRs and their Alternate should attend the 4 Full Area Assemblies each year, as well as their own monthly district meeting as part of their service to their group.
